Dear Parent or Guardian,

I hope this letter finds you well. We have recently been informed that as of Monday January 3, 2022 Philadelphia, Pennsylvania establishments that sell food or drink for consumption onsite will require that everyone who enters has completed their COVID vaccinations. Completing vaccinations means that they have completed the series of any vaccine that has been approved or authorized by either he Food and Drug Administration or the World Health Organization to prevent COVID-19. At this time, it does not mean that you need to have received a booster dose. This includes Spirit Cruises and Mimi's Philly Gourmet Steak.

While this is a city rule, and not a Lynbrook School District policy, we must adhere to rules and regulations put forth by government entities. With that being said, all students attending the Philadelphia Music Department Trip must be fully vaccinated. It must also be understood that if there is not enough participation to support an ensemble's performance, the district reserves the right to cancel that ensemble's participation in the trip.

We will follow up with another letter requesting vaccination documentation in order to ensure we have participation for each ensemble.

Each year we try to provide the musicians of the Lynbrook High School music department the opportunity to perform for audiences far and wide. Some of our most notable shows include marching down Main Street in Disney World, playing in front of Faneuil Hall at Quincy Market in Boston, MA, competitions at Six Flags New England, Six Flags Great Adventure, Six Flags Great America, and Busch Gardens in Virginia, performing alongside world-renowned violinist Mark Wood, holding a concert at Carnegie Hall in NYC, as well as performing a concert on the steps of the Lincoln Memorial in Washington, DC.

This year will be no different. The LHS Band, Chorus, and Orchestra will be performing a concert in front of the historic Liberty Bell in Philadelphia, Pennsylvania. In an effort to maintain the health and safety of students and chaperones, all attendees will be required to take a Covid-19 PCR test within 48 hours of the trip departure. This will be provided to all trip attendees at LHS on Monday, May 16th, 2022. Students who do not produce a negative test will not be permitted to attend the trip.

Departing from Penn's Landing, the Spirit of Philadelphia Lunch Cruise includes a narrated sail along the Delaware River, highlighting the attractions along the way. Trip Rules

This is not an all-encompassing list. This is just a starting point for all the things we expect out of every student participating in this trip.

- a) Students must be on time (or early) for all check-ins and meeting times. This includes everything from arrival at LHS early Wednesday morning to attendance following each activity, etc. Check-ins must be done in person.
- b) During any given time, NO student is to walk around by themselves. All students must walk around with at least one other student at all times.
- c) There is ABSOLUTELY NO smoking, vaping, drugs, alcohol or illegal substances/paraphernalia permitted in any form, at any time.
- d) Students must wear the provided Lynbrook t-shirt at all times.
- e) NO modifications can be made to the Lynbrook t-shirts. They must be worn as is.
- f) The Lynbrook t-shirt must be the outermost layer at all times.
- g) Students must check their cell phones throughout each day. Chaperones must be able to contact students at any time.
- h) Communication tools used on the day of the trip, such as the Remind app or a school cell phone, are reserved solely for communication between chaperones and students.
- i) Students must travel on their assigned bus.
- j) Students must quietly and respectfully watch any other Lynbrook group's performance that they are not participating in.
- k) The use of public transportation is strictly prohibited.
- 1) All bags and instrument cases are subject to inspection at any time.
- m) If any student(s) should observe an inappropriate situation that violates any of these rules or the Lynbrook Code of Conduct, it is the responsibility of the student(s) witnessing the event to report the incident immediately to a chaperone.
- n) Face masks must be worn in all indoor venues and on the coach bus.

Remember: There will be families and other groups at our performance, and some of the tour stops. We expect you to be on your absolute best behavior at all times. You're representing Lynbrook. We take this seriously, and you must too!
